- a. Recognition of new hires, including Dr. Wallace, the new County Veterinarian, starting April 3<sup>rd</sup>. Ms. Katherine Fielder, promoted to Animal Services Operations Supervisor, and Klayton Rasmussen will be the Maintenance Engineer III.
- b. Recognition of Deirdre McGrath, Deputy County Counsel, who works diligently behind the scenes.
- c. IT Technology grant through SBT. SASA submitted three applications for IT solutions.
  - 1. Citizens to have access to their own account in process.
  - 2. Customer Service IVR Voice activated license pay in process.
  - 3. Web Mobile Chameleon System Tablets for Canvassing allowing live data as well as data entry complete
- d. Thanks to a generous \$10,000 donation, Animal Services had 130 animals adopted into new homes last December. The donation covered the cost of these adoptions.
- e. Facebook Live is a new tool being utilized by SASA.
- f. Flood Preparations continue. SASA has access to the Stanislaus County Fairgrounds any time it is needed.
- g. PetCo also provided SASA a \$4000 donation in December and our offsite adoptions are doing well.
